This module addresses politics and policy-making in the European Union, with applications to supranational and national government as well as to issues belonging to the specific policy domain of health care and public health. Specifically, it looks at the regulatory impact of EU integration on political institutions, on health systems governance and management, and on public health regulations at all levels of government.

By design, this course will approach the European Union as an empirical, a theoretical and a practical challenge. First of all, how does the European Union influence the general patterns of policy-making? Then, what are the theoretical frameworks that explain how these politics developed over time? And finally, what practical lessons can be drawn from the current European experience with regional and market integration?

The emphasis of the course is set on the understanding of the legal and political orders that apply within the European Union at the national and supranational levels. The course relies on concepts such as governance, judicialization and Europeanization, which are articulated in a general framework of understanding that can then apply to other political areas subject to regional integration and/or federal regulation.

No previous knowledge in any of these topics is required for taking the course, but some interest in comparative politics and public policy will naturally prove useful.
